



## 2018 ELIGIBILITY CRITERIA

### NEW BUSINESS OF THE YEAR

- **Nominees must approve and accept this nomination in written form to [nominations@halifaxchamber.com](mailto:nominations@halifaxchamber.com)**
- Nominees must have an active business located or operating in Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
- Nominees must have been in business less than two years as of August 31, 2017.
- Nominees cannot be an expansion of an existing business, name change or new location of an existing organization.
- Please note: Not for Profits/Crown Corporations/Government Funded Facilities are not eligible for this category.

### SMALL BUSINESS OF THE YEAR

- **Nominees must approve and accept this nomination in written form to [nominations@halifaxchamber.com](mailto:nominations@halifaxchamber.com)**
- Nominees must have an active business located or operating in Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
- Nominees must be an independently owned and operated business with a total number of employees not exceeding 25.
- Business must be owner operated for a minimum of two years, as of August 31, 2017.
- Please note: Not for Profits/Crown Corporations/Government Funded Facilities are not eligible for this category.

### EXPORT BUSINESS OF THE YEAR

- **Nominees must approve and accept this nomination in written form to [nominations@halifaxchamber.com](mailto:nominations@halifaxchamber.com)**
- Nominees must have a business operating out of Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
- A minimum of 40% of customers, partners or revenues must come from markets outside of Canada.
- Please note that Not for Profits/Crown Corporations/Government Funded Facilities are not eligible for this category.

## **INNOVATIVE BUSINESS OF THE YEAR**

- **Nominees must approve and accept this nomination in written form to [nominations@halifaxchamber.com](mailto:nominations@halifaxchamber.com)**
- Nominees must have an active business located or operating in Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
- Nominees must have introduced an innovative product or service on or before August 31, 2017, or be operating in a mode where innovation is built into the culture of the company.
- Please note that Not for Profits/Crown Corporations/Government Funded Facilities are not eligible for this category.

## **BUSINESS OF THE YEAR**

- **Nominees must approve and accept this nomination in written form to [nominations@halifaxchamber.com](mailto:nominations@halifaxchamber.com)**
- Nominees must have an active business located or operating in Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
- Nominees must have been in business more than two years as of August 31, 2017.
- Nominees must have a total number of employees exceeding 25.
- Please note: Not for Profits/Crown Corporations/Government Funded Facilities are not eligible for this category.

- Nominees must have an active participation in a business located or operating in Halifax. The majority of the business must have provincial ownership and headquarters must be located provincially.
